Tampa's crew totaled 130 men, including 111 Coast Guardsmen, four US Navy personnel, and 15 British Navy sailors and dockworkers.
- those interested in the study of identity and ideology, an exploration of ASALH's Black History themes is itself instructive. Over the years, the themes reflect changes in how people of African descent in the United States have viewed themselves, the influence of social movements on racial ideologies, and the aspirations of the black community.

In addition, my first two visits to the MOPH Headquarters (HQ) were productive and I want to thank the HQ Staff (Jesseca Voorhies, Membership/Office Manager, and Caira Grey-Johnson, Communications Specialist) for their support when I work from either home or at the National HQ. I also thank National Finance Officer, Ernie Rivera for his 11-14

October 2023 visit and National Commander Carder Ferguson; National Junior Vice Commander, Tracey Brown-Greene; Deputy National Finance Officer, Jim Anderson; National Judge Advocate Walter Kroptavich; Madame Auxiliary President Barbara Ray; and Department of Colorado Senior Vice Commander, Roy Ray for their 07-12 November 2023 visit to the National Headquarters (HQ) ensuring that the business of the Order is being carried out in an effective manner.

A special BIG THANK YOU goes to NSVC Tracey Brown-Greene for her most outstanding job in cleaning up and organizing the downstairs areas of the National Headquarters. Criticism from a recent Patriot's visit to the Headquarters on the chaotic appearance of Building B was well warranted, but thanks to NJVC Brown-Greene and her superb organizational skills and the assistance from the Rays, there is a 1000% improvement. BLDG B is now something the MOPH can be proud of to have folks visit!

During the past four months, a lot has been accomplished by the Leadership Team. Some of the accomplishments are:

(Re)Hired) Ms. Caira Grey-Johnson as the Communications Specialist. It is great to welcome her back on the MOPH Team.

Accomplished a lot in getting the Bylaws updated by inserting the Amendments approved during the 2022 and 2023 National Conventions. There were some formatting and numbering issues carried over from previous updates that could not be overcome on the HQ computers, so DNFO

Jim Anderson and I had to work on finishing the Bylaws from home. The good news is, the updated Bylaws were sent out by Constant Contact and are posted on the MOPH website. Many Thanks Jim!

Insurance Audit completed resulting in a refund from one insurance company.

Changed Insurance companies and obtained new policies resulting in a reduction in premiums on required coverages (i.e., Workers Compensation, Property Theft and Loss)

Internal Revenue Service (IRS) Federal Employer Identification Number (FEIN) Group Exemption Audit completed. This included all Departments, Chapters, and the entire Auxiliary. This will ensure that the MOPH/MOPHA National Headquarters, and active Departments, Chapters/Units will maintain their tax-exempt status. However, 990Ns must still be filed with the IRS.

~~~Special Note regarding the FEINs: This year MOPH had a Department file a request for an extension to file income taxes using the MOPH HQ FEIN. It has also been noted that there are Departments and Chapters filing their IRS 990Ns using the MOPH HQ FEIN. This must stop immediately! Please check and ensure the FEIN you are filing belongs to your Chapter/Department and not the MOPH HQ. Should you need assistance in verifying your Chapter/Department FEIN, please call the National Adjutant.

Formally closed Revenue/Income Tax, Employment Tax, and Unemployment Compensation and Insurance Tax Accounts in several cities, counties, and states that were still billing the MOPH even though we have not had employees there since 30JUNE2020.

Renewed the MOPH Business Licenses in the State of Virginia (where we are based) and Washington DC (where we are chartered).

Inventoried on hand National Leadership Awards and placed an order to ensure sufficient quantities are available to meet projected needs by Departments/Chapters for the "Spring 2024 Awards Presentation Season".

Processed and shipped several the current National Leadership Awards that were already on order. Per the USPS Tracking system, all were received at the address to which shipped.

Fixed the US Flag and the MOPH National Flag poles and had the MOPH National Flag cleaned and pressed.

Repaired the flappers in both toilets and replaced over 50 light bulbs at the Headquarters and changed out the two HVAC filters. Still need to replace one toilet handle, fix the shower knob, and patch two small holes in a downstairs wall (will be done during my next visit). Worked in the Bookkeeper's office and sorted and organized the finance files. We made a lot of progress but still have a long way to go.

Was able to get the check scanner installed to make depositing checks received at the HQ BLDG easier without even having to leave the office.

Shut down our old server and changed out the computer at Communications Specialist area and upgraded the Communications' and Adjutant's computers from Windows 7 to Windows 10.

NJA Kroptavich reviewed some contracts up for renewal and provided some sound legal advice on those and also on some other pending issues. Along with Patriots Dennis Wallot (Chair, National Finance Committee) and Ed Abbey (Adjutant, Region IV), he also reviewed a proposal from the Association of the United States Army that will provide some benefits at no cost to the MOPH or its members and regardless of Military Branch in which they served.

Printed and mailed the new Charters for new, recently reactivated, or renamed Chapters.

Reformatted the National Leadership Awards. Jesseca printed 1500 leadership certificates. MOPHA President Barbara Ray and DSVC-CO Roy Ray helped stuff them in the folders for future orders and consolidated all products for awards downstairs in the shipping room.

Had the Commonwealth Copy Machine salesman (Al Waters) stop by, and we had a very intense discussion about the new Commonwealth proposal and our Copier needs. Closed out two copiers so that MOPH is no longer charged for service, supplies or copies.

Visited US Congressman Steve Womack's Office (R-ARK), where National Commander Ferguson and National Adjutant Adkins met with Congressman Womack and his staff to

discuss issues that are important to the Order, which if implemented, will improve benefits received by all Veterans and thereby improving their lives.

Participated in the US Department of Veterans Affairs Veterans Day Wreath Laying Ceremony at the Tomb of the Unknown Soldier, Arlington National Cemetery. Have since learned the MOPH is scheduled to sponsor the event in the year 2029.

NEC Ballot to confirm the National Commander's appointment of Past National Commander James McCormick as the National Legislative Director. Welcome back to active service James! Look forward to you leading the way on legislative issues important to the MOPH and the Veterans community as a whole. Let's get started with the MOPH Legislative Resolution on changes to the Survivor's Benefits Program (SBP) passed during the 2019 National Convention.

With the turn of the New Year, Chapters and Departments must now focus on the tasks ahead in order to prepare for the 2024 National Convention in Orlando Florida. First comes the election of new Chapter and Department Officers for the 2024-2025 year. Be sure to check the Bylaws for the changes made concerning Chapter Delegates to the Department and National Elections. The changes made during the 2021National Convention has made this requirement less burdensome. (see Bylaws Article VIII).

In addition, there are several required Annual Reports, but the BIG FOUR (Election, Finance with Property Report attached, IRS 990N, and Life Member Verification Report) can make or break a Chapter/Department. For example, should a Chapter/Department fail to submit an Election Report, it immediately goes on Inactive Status and therefore is not authorized to operate, expend funds, unable to receive Life Member Rebates, and is subject to closure. Failure to submit a Life Member Verification Report (LMVR) will also result in not receiving the Rebates. Filing the IRS 990N is to ensure the MOPH HQ, Departments, and Chapters are following federal tax laws and maintain our tax-exempt status.

The Finance with Property Report is to ensure we are properly accounting for our monetary and material resources. However, the Leadership team is exploring the idea that the Chapter Finance and Property Reports need to go no further than the Department level. The Department will then send a report to the National Headquarters that both the Department and Chapter Finance with Property Reports have been completed (more to follow on this). Then only the Department and Chapter 990s are required to be submitted online to the HQ for IRS reporting purposes. *Again, be sure to use the correct FEIN!* 

As for the Welfare, Americanism, and VAVSO; these reports are the most often ignored but they should not be. They provide information to our National Headquarters and in turn Congress relating to matters of Rehabilitation, Welfare, and Service-related Legislative Activities.

All Reports should be turned in in an accurate and timely manner. Be sure to follow the Bylaws, use the on-line Key Filing

Dates, and check the online Reports Tracker to assist you in submitting the BIG FOUR by the required suspense dates and to ensure that MOPH HQ gives credit for submission.

Speaking of the National Convention, The Leadership Team is working with the Department of Florida on the planning and executing on what will be an awesome event. Dates are 15-17 July 2024 in Orlando Florida. More details to follow—keep an eye on the MOPH website where key National Convention information will soon be posted. *Please plan to attend!* 

Finally, I continue my pledge that the MOPH Headquarters Team will be responsive to your requests for information and work in an open environment while protecting the rights and privacy of all concerned. As always, please treat the HQ Staff in the same respectful manner in which I expect them to treat you.

(Ephesians 6:10-20)

Prayer too often plays second fiddle to the myriad of other tasks in our lives. The busyness of our lives crowds out the business of our prayers! Considering there are many kinds of prayer, we tend to treat public prayer as the standard; but this is a great mistake because it tends to promote a formalistic attitude to prayer itself. Here are some kinds of prayer:

**Public** prayer. Acts 20:36: "And when he [Paul] had said these things, he knelt down and prayed with them all." (See also the prayers of Solomon in 1 Kings 8:22-53, and Ezra in Ezra 9: 5-15.)

**Private** prayer in a group setting. Acts 16:13: "And on the Sabbath day we went out of the city to the riverside, where prayer was customarily made."

**Secret** prayer. Matthew 6:6: "But you, when you pray, go into your room, and when you have shut the door, pray to your Father who is in the secret place; and your Father who sees in secret will reward you openly."

Mental prayer. 1 Samuel 1:13: "Now Hanna spoke in her heart, only her lips moved, but her voice was not heard. "Nehemiah 2:4: "Then the King said to me, 'What do you request?' So, I prayed to the God of Heaven and I said to the King...."

**Occasional** prayers. 1 Chronicles 5:20: "And the Hagrites were delivered into their hand and all who were with them, for they cried out to God in the battle. He heard their prayer for they put their trust in Him."

NEVER FORGET that WE CONSTANTLY
STAND IN THE NEED OF PRAYER; and that
prayer is never needed so that God can be
informed about what's happening, or so
that He can change His eternal mind. He
declares the end from the beginning (Isa.


#### **Visiting Pearl Harbor 2023**

## **Thoughts on Pearl Harbor Day 2023**

December 7, 2023, I am awake early excited to attend the 82<sup>nd</sup> National Pearl Harbor Remembrance Ceremony, A Legacy of Hope. As excited as I am, I am also

wondering, what was on the minds of all the men, women, and children on the Island that December 7, 1941, morning. What plans and hopes were they thinking of for the coming day, month, or year? For approximately 2400 people, we will never know their hopes and dreams. Survivors of Pearl Harbor still remember that Sunday morning, was it a practice drill, maneuvers, or an invasion of the Hawaiian Islands? As the planes approached, red circles of the Rising Sun on their wingtips were seen, in disbelief, everyone sprang into action and began to open fire.

The wreckage of the USS Arizona remains as a monument to the events of World War Two and to the legacy of those who sacrificed their lives to preserve our most cherished values. As I walked closer to the "Remembrance Circle" a chill came over me and I looked up to the sky and wondered how the chills came over everyone on that Sunday morning that were looking up to the sky, wondering what was happening and to the sailors still in their bunks after hearing the sounds of gunfire and bombs.

The National Pearl Harbor Remembrance Day Commemoration Ceremony started at 7:50 AM Hawaiian time. After a Moment of Silence, a Missing Man Flyover Formation, Presentation of Colors, National Anthem / Hawai'i Pono'i, a Pass-in-Review by the USS Decatur (DDG-73) slowly moved in front of the attendees and the USS Arizona. My eyes became a little misted knowing I was in attendance at such a special occasion and how honored to be a participant. They keynote speaker, U.S. Marine Captain Ray Daniel Hower is the son and grandson of U.S. Marine Corps pilots. His Great Uncle Lou Conter was aboard the USS Arizona during the Pearl Harbor attack and is now its only living survivor and flew PBY Catalinas throughout the Pacific during World War Two. Captain Hower wears the pilot wings his Great Uncle wore. Wreath presentations, Benediction, Rifle Salute, and Echo Taps & Postlude ended the Remembrance Day Commemoration Ceremony.

The USS Arizona was not the only vessel to be remembered on this day, the USS Utah and USS Oklahoma had their own ceremonies. Let us remember all who perished or were wounded and also the few survivors who are still living and experienced the site and loss of their friends.

"Legacy of Hope" keynote speaker, U.S. Marine Captain Ray Daniel Hower says "It's important for future generations to understand, that the Legacy of Hope was born out of the Greatest Generation, and almost all of us are descendants of that generation and thus inherited the legacy.

We all bear a responsibility to honor it, respect it, and build upon it."

Our generation needs to make sure the generations to follow us know the sacrifice all Veterans have made to make this country great. Thank you for giving me the honor of attending this amazing and humbling ceremony.

#### **Public Health Service**



The United
States Public
Health Service
Commissioned
Corps (US
PHSCC), also

referred to as the Commissioned Corps of the United States Public Health Service, is the uniformed service branch of the United States Public Health Service (PHS) and one of the eight uniformed services of the United States alongside the United States Army, Navy, Marine Corps, Coast Guard, Air Force, and Space Force and the NOAA Commissioned Officer Corps. The commissioned corps' primary mission is the protection, promotion, and advancement of health and safety of the general public.

Along with the NOAA Commissioned Officer Corps, the Public Health Service Commissioned Corps is one of two uniformed services that consist only of commissioned officers and has no enlisted or warrant officer ranks, although warrant officers have been authorized for use within the service. Officers of the commissioned corps are classified as noncombatants, unless directed to serve as part of the military by the president or detailed to a service branch of the military. Members of the commissioned corps wear uniforms modeled after the United States Navy and

the United States Coast Guard, with special PHS Commissioned Corps insignia, and hold naval ranks equivalent to officers of the Navy and Coast Guard, along with corresponding in-service medical titles. Commissioned corps officers typically receive their commissions through the commissioned corps' direct commissioning program.

As with its parent division, the Public Health Service, the commissioned corps is under the direction of the United States
Department of Health and Human Services.
The commissioned corps is led by the surgeon general, who holds the rank of vice admiral (O-9). The surgeon general reports directly to the Department of Health and Human Services Assistant Secretary for Health. The assistant secretary for health may be appointed to the rank of admiral (O-10) if they are also a serving uniformed officer of the commissioned corps.

## The Saga of the Four Chaplains

It was the evening of Feb. 2, 1943, and the U.S.A.T. Dorchester was crowded to capacity, carrying 902 service men, merchant seamen and civilian workers. Once a luxury coastal liner, the 5,649-ton vessel had been converted into an Army transport ship. The Dorchester, one of three ships in the SG-19 convoy, was moving steadily across the icy waters from Newfoundland toward an American base in Greenland. Coast Guard Cutters Tampa, Escanaba, and Comanche escorted SG-19.

Hans J. Danielsen, the ship's captain, was concerned and cautious. Earlier the Tampa had detected a submarine with its sonar. Danielsen knew he was in dangerous waters even before he got the alarming information. German U-boats were constantly prowling these vital sea lanes, and several ships had already been blasted and sunk.

The Dorchester was now only 150 miles from its destination, but the captain ordered the men to sleep in their clothing and keep life jackets on. Many soldiers sleeping deep in the ship's hold disregarded the order because of the engine's heat. Others ignored it because the life jackets were uncomfortable.

On Feb. 3, at 12:55 a.m., a periscope broke the chilly Atlantic waters. Through the cross hairs, an officer aboard the German submarine U-223 spotted the Dorchester. U-223 approached the convoy on the surface, and after identifying targeting the ship, he gave orders to fire the torpedo and a fan of three were fired. The one that hit was decisive--and deadly--striking the starboard side, amid ship, far below the water line.



Danielsen, alerted that the Dorchester was taking water rapidly and sinking, gave the order to abandon ship. In less than 20 minutes, the Dorchester would slip beneath the Atlantic's icy waters.

Tragically, the hit had knocked out pov and radio contact with the three escort ships. The CGC Comanche, however, saw the flash of the explosion. It responded and then rescued 97 survivors. The CGC Escanaba circled the Dorchester, rescuing an additional 132 survivors. The third cutter, CGC Tampa, continued on escorting the remaining two ships. Aboard the Dorchester, panic and chaos had set in. The blast had killed scores of men, and many more were seriously wounded. Others, stunned by the explosion, were groping in the darkness. Those sleeping without clothing rushed topside where they were confronted first by a blast of icy Arctic air and then by the knowledge that death awaited.

Men jumped from the ship into lifeboats, over-crowding them to the point of

capsizing, according to eyewitnesses. Other rafts, tossed into the Atlantic, drifted away before soldiers could get in them. Through the pandemonium, according to those present, four Army chaplains brought hope in despair and light in darkness. Those chaplains were Lt. George L. Fox, Methodist; Lt. Alexander D. Goode, Jewish; Lt. John P. Washington, Roman Catholic; and Lt. Clark V. Poling, Dutch Reformed.



Quickly and quietly, the four chaplains spread out among the soldiers. There they tried to calm the frightened, tend the wounded and guide the disoriented toward safety. "Witnesses of that terrible night remember hearing the four men offer prayers for the dying and encouragement for those who would live," says Wyatt R. Fox, son of Reverend Fox.

One witness, Private William B. Bednar, found himself floating in oil-smeared water surrounded by dead bodies and debris. "I could hear men crying, pleading, praying," Bednar recalls. "I could also hear the chaplains preaching courage. Their voices were the only thing that kept me going."


Another sailor, Petty Officer John J. Mahoney, tried to reenter his cabin but Rabbi Goode stopped him. Mahoney, concerned about the cold Arctic air, explained he had forgotten his gloves.

"Never mind," Goode responded. "I have two pairs." The rabbi then gave the petty officer his own gloves. In retrospect, Mahoney realized that Rabbi Goode was not conveniently carrying two pairs of gloves, and that the rabbi had decided not to leave the Dorchester.

By this time, most of the men were topside, and the chaplains opened a storage locker and began distributing life jackets. It was then that Engineer Grady Clark witnessed an astonishing sight.

When there were no more lifejackets in the

storage room, the chaplains removed theirs and gave them to four frightened young men. "It was the finest thing I have seen or hope to see this side of heaven," said John Ladd, another survivor who saw the





Ladd's response is understandable. The altruistic action of the four chaplains constitutes one of the purest spiritual and ethical acts a person can make. When giving their life jackets, Rabbi Goode did not call out for a Jew; Father Washington did not call out for a Catholic; nor did the Reverends Fox and Poling call out for a Protestant. They simply gave their life jackets to the next man in line.

As the ship went down, survivors in nearby rafts could see the four chaplains' arms linked and braced against the slanting deck. Their voices could also be heard offering prayers.



Of the 902 men aboard the U.S.A.T. Dorchester, 672 died, leaving 230 survivors. When the news reached American shores, the nation was stunned by the magnitude of the tragedy and heroic conduct of the four chaplains.

"Valor is a gift," Carl Sandburg once said.
"Those having it never know for sure whether they have it until the test comes."

That night Reverend Fox, Rabbi Goode, Reverend Poling and Father Washington passed life's ultimate test. In doing so, they became an enduring example of extraordinary faith, courage, and selflessness. The Distinguished Service Cross and Purple Heart were awarded posthumously on December 19, 1944, to the next of kin by Lt. Gen. Brehon B. Somervelle, Commanding General of the Army Sea Forces, in a ceremony at the post chapel at Fort Myer, VA.

A one-time only posthumous Special Medal for Heroism was authorized by Congress and awarded by the President Eisenhower on January 18, 1961. Congress attempted to confer the Medal of Honor but was blocked by the stringent requirements that required heroism be performed under fire. The special medal was intended to have the same weight and importance as the Medal of Honor.



#### **Legislative Agenda**

The course of action that I propose the MOPH take regarding legislative initiatives should be robust, beneficial to all veterans and put us in the lead regarding some of these efforts. We have historically taken the position of supporting other VSO efforts and becoming more of a cosigner regarding legislative efforts. This is something we can still maintain as a show of good faith. However at this point in life it is time for the MOPH to step into the lead on some efforts that we know will be of great benefit to the veteran community and also put our name on the lips of elected officials and donors who will see our value as being courageous champions for our fellow veterans.

In 2020-2021 the MOPH with Gold Star families and the Marine Corps league in cooperation with the National Flag Foundation scored a major victory that we took lead on and that was the addition of a national DOD database for Purple Heart recipients and held the nation's first Light to Unite effort that drew in thousands of business owners who donated time, money and advertising for the MOPH.

In my significant time navigating the world of legislative efforts and knowing, that it can at times be a cutthroat operation I feel the best course of action is attack these three efforts with a full-frontal assault and pull in support before the end of the fiscal year. In addition, we need to build up a legislative force in each department and region so we

can collectively work on federal and state initiatives that will position us to be effective and victorious. Losing is not going to help anyone, kicking the ball offside will not help either, we need a serious effort from serious team players to get this job done and that is why I am asking that each department provide one legislative person who will be willing to have a monthly zoom meeting and participate in the efforts of the MOPH legislative efforts. I suggest we set a meeting date and time of 20:00 on the last Thursday of each month starting January 25.

Three efforts we should start pushing immediately.

 Honorably discharged veterans over the age of 85 years old should receive access to VA health care and a pension for their honorable service to America. Sadly, even our few WW2 veterans have to qualify for services; they need to have a verified disability rating and cannot make over a certain amount of money to get access to healthcare. This is a disgrace, if any organization should be leading the charge on this it should be the MOPH! Our bill should lay out that the only qualifier be an Honorable Discharge and be 85 and 1 day old to start to immediately receive VA healthcare access. This would be regardless of disability rating or income status and start to receive a pension of \$100 a month in addition to any other retirement, VA Compensation and call it Honor Pay for those who honorably serve and have lived to the age of 85, in our

- world that is an amazing accomplishment and we need to do better for our aging veterans regardless of their disability rating, combat service etc. Honorable Service should be honored.
- 2. Military Honors Act: Add all combat awards and decorations to the current protected status of the Medal of Honor, additionally add that the use of any award, image or award that falls under this protection for any purpose by non-recipients of same awards shall be requested through the Office of Heraldry. Adding that no congressional veterans service organization should be denied rights to use these same military awards images and names for the purpose of advertising, recruiting or fundraising efforts. Furthermore, any private, non-congressionally chartered organization shall not be permitted to trademark, wordmark of hinder the use of authorized and protected status military awards and decorations by legitimate veterans and recognized organizations. The department of defense shall be authorized and required to investigate and take appropriate actions to remedy any such actions that violate this law to include charging and seeking financial restitution for violations of this law. Any organization who has current trademarks and or wordmarks of military awards or related to the same shall immediately have them
- revoked and a complete list of protected awards and names shall be provided to the US Patent and Trademark office to prevent further degradation and demeaning of our hallowed and protected awards.
- 3. Add to the current Purple Heart database a mechanism for veterans and families of veterans to submit verified proof of the awarding of the Purple Heart medal and add a link to the Military Order of the Purple Heart website that the DOD shall share with visitors seeking additional information on the Purple Heart award.





Each man personally signed every bottle produced.

Bob Bleier was a quarterback who played for the New England Patriots during the late 1980's. He now has a wealth management firm in Pittsford, N.Y., just a short ten miles from the Iron Smoke tasting room. He was already aware of the fine bourbons produced by Iron Smoke, which is an internationally acclaimed New York State farm distillery located in the Finger Lakes region of Upstate New York.


Bleier's Bourbon was quietly released to a targeted audience at the beginning of November 2023, right before Veteran's Day. Both Rocky and Bob Bleier personally signed every one of the 546 bottles that were available from the first batch. It is currently being marketed to a wider group and the response has really grown.

"I had the opportunity to speak at several Veteran's Day events over the span of a couple of weeks which got the ball rolling. Then, the holiday season was a perfect time for gift-giving. Now, as more and more people realize that sales of this bourbon will help veterans secure housing and assist them in getting mental health services, they immediately start asking how they can get a bottle."

Bleier is well known in Pittsburgh, PA., having won four Super Bowls championships while a running back for the Steelers. Yet, fellow military members point to the Bronze Star and Purple Heart Rocky was awarded after he served in South Vietnam with the 196<sup>th</sup> Light Infantry Brigade. It was August 20, 1969, that his brigade was ambushed in a rice paddy.

Rocky took a bullet in his left thigh. His right foot was also severely damaged when a grenade exploded nearby. Despite his injuries, Rocky was determined to go back to playing football after he recovered.

Rocky Bleier was awarded a Purple Heart for injuries he sustained while serving in Vietnam in 1969. Despite bullet wounds to his left leg and severe damage to his right foot from a grenade explosion, he overcame his disabilities and returned to play football with the <a href="Pittsburgh Steeler">Pittsburgh Steeler</a>s. Rocky helped his team win four NFL championships in the 1970's and at retirement in 1980, he was the Steelers fourth all-time leading rusher.



"After I left the NFL, I devoted my time to honoring the bravery and resilience of my fellow Purple Heart brothers," declared Rocky Bleier. "I want

to make sure their legacy is forever etched in the heart of our nation. So, with this bourbon, I raise my glass to their selfless service."

"There's no stopping a man with a mission. He's 77 years old now, so it's even more important to him to leave a legacy of philanthropy and helping his fellow veterans, said Bob Bleier. "

Rocky and Bob took classes to be certified bourbon stewards and then went to different distilleries to find one that could make a bourbon with a distinctive flavor profile for their Purple Heart Bourbon. "We wanted every sip to reflect the indomitable spirit of those who have served our great nation. I think we have achieved that thanks to the superlative craftsmanship of Iron Smoke," said Rocky Bleier.

### George Washington,

First President of the United States

Born 1732, died 1799. Washington led the colonists in the American Revolutionary War to win independence from Great Britain. He was the father of the new country and laid the foundation of American democracy. Because of his importance, Borglum chose Washington to be the most prominent figure on the mountain and represent the birth of the United States.

#### **Thomas Jefferson**

Third President of the United States

Born 1743, died 1826. Jefferson was the primary author of the Declaration of Independence, a document which inspires democracies around the world. He also purchased the Louisiana Territory from France in 1803 which doubled the size of our country, adding all or part of fifteen present-day states. Gutzon Borglum chose

Jefferson to represent the growth of the United States.



# **Fun Facts About George Washington**

revered soldier and political leader, George Washington was the Father of our country and has always been one of the most iconic figures in American history. His eulogy, delivered by Major General Henry "Light Horse Harry" Lee, immortalized the words, "to the memory of the man, first in war, first in peace, first in the hearts of his countrymen." That farewell address is one of the most famous speeches in American history. Over the years, many facts and

myths have become associated with our country's first president. Here are some **george-washington-facts** that may surprise you about the man that his friends and wife called "General."

#### He Was a Stickler for Dates

When Washington was born on February 22, 1732, the Virginia colonies used the old style Julian calendar. The colonies later adopted the current, new style Gregorian calendar that we still use today. The switch

resulted in dates being moved back 11 days. Washington preferred the original 2-22, and his birthday is still celebrated on that date.

### He's a Scholar in Name Only

Although several universities and other educational institutions bear his name, Washington did not attend college. He is the only major founding father without a college education. He left school at the age of 15 because his family could not afford his college education. As a result, he was self-taught in many fields. His knowledge of the countryside and map-making skills as a surveyor enabled him to serve with distinction during the French and Indian War, in which he fired the first shot.

# **His Choppers Weren't Chopped From Wood**

Believe it or not, Washington's false teeth were not made from wood. They were created using a combination of gold, ivory, carved animal bone and human teeth purchased from his African American slaves. The purchase records still exist. He used his false teeth to eat hoecakes, his favorite breakfast; simple cornmeal pancakes served with butter and honey.

Washington ruined his teeth using them to crack walnut shells. The dentures he had were made out of lots of things, but not

wood. Instead, they came largely from human teeth, pulled from the mouths of the poor and his enslaved workers. They also came from ivory, cow teeth and lead. He had a little spring inside the dentures that helped them open and close.

The fake teeth caused him great discomfort, and were one of the reasons he rarely smiled. He had to have his morning hoe cakes and syrup (chosen for their softness) cut into tiny pieces to make them easier to eat.

### He Was an Elitist, Rule Follower

Although he supported the sentiment that gave rise to the Boston Tea Party,
Washington condemned the act. In 1774,
Washington wrote that the cause of Boston was the same as that of America, but he also strongly voiced his disapproval of the event. Like many elites, Washington held that private property rights were paramount, so he viewed the action of the rebels as an act of vandalism rather than a patriotic statement. Washington believed that those involved should compensate the British East India Company for the damages they caused.

#### He Defied Death

Washington led troops in numerous military engagements, but despite commanding several well-known victories Washington lost more battles than he won during the Revolutionary War. In the French and Indian War, Washington had two horses shot out from under him and received four bullet holes in his coat as well as one in his hat. This perceived immunity to bullets led one Indian chief to remark that some higher power must be guiding his life. During the Nation's Bicentennial, Washington was posthumously promoted to General of the Armies of the United States, the highest rank in the U.S. military. A 2012 poll conducted in Great Britain ranked Washington, not Napoleon, as the British Empire's greatest military adversary. Although he made some battlefield blunders, Washington provided the leadership that was required to hold the **Continental Army** together for the eight years it took to achieve victory.

A tall and robust man, Washington survived multiple life-threatening situations. At various points, Washington had diphtheria, tuberculosis, smallpox, malaria, dysentery, Quinsy, carbuncle, and pneumonia. He survived near drowning in an ice-clogged river. He survived the burning and massacre of Fort Necessity. He survived two horses being shot out from under him and four bullets passing close enough to pierce his clothing—all in one battle.

Ironically, it was a cold that did him in.

Technically, it was epiglottitis, an infection of the back of the throat that would be

curable with antibiotics today. While he lay dying, his doctors effectively tortured him—burning him to remove the sickness and draining him of a full 40 percent of his blood. Washington was fearful of being buried alive, as he was convinced others in history had been. He directed that his body not be buried for three days after his death, just in case.

#### He Was a Volunteer

The only president to unanimously receive all electoral votes, Washington never actually ran for president; he was drafted by popular demand. This feat was accomplished for both his terms. He refused to accept a salary as president and even spent some of his own money to pay the salaries of cabinet ministers and other members of the executive branch. Although instrumental in developing the plans for the District of Columbia and the White House, Washington never lived in the city or the Presidential Mansion. His inaugurations took place in New York and Philadelphia, the capital cities at that time.

# **His Ideas Became Presidential Traditions**

Washington added the phrase "So help me God" to the end of the Presidential Oath of Office during his inauguration and it has been delivered in that manner ever since. It was his idea to the call the chief executive "Mr. President." He is also the inspiration for the two-term limit for the presidency and it was he who issued the first Thanksgiving Proclamation designating November 26 as a national holiday.

### He Was an Entrepreneur

While serving a president, he personally led, as Commander-in-Chief, the troops that suppressed a tax revolt in 1791 that came to be known as the Whiskey Rebellion.

Washington was actually one of the new nation's most successful liquor distributors. He constructed a state-of-the-art distillery at his Mount Vernon home. It produced rye whiskey as well as apple and peach brandy. At one point, the distillery was producing 11,000 gallons of whiskey per year. The form of whiskey produced was similar to today's moonshine, which led to the myth that Washington was a moonshiner. The restored distillery is open for public tours.

# **He's the Face of the Nation in More Ways Than One**

Only Washington and Abraham Lincoln are featured on both a U.S. coin and bill currently in circulation. While a likeness of Lincoln adorns the penny and five-dollar bill, Washington is honored with the quarter and the \$1 bill. Washington was also featured on the country's first postage stamps. He has appeared on more issues than all the other presidents combined have.

# Did He or Didn't He Cut Down That Cherry Tree?

One of the myths associated with Washington, that he chopped down the cherry tree, traces back to a biography written shortly after his death. The book's author, Parson Weems, told several tall tales. True or not, the story of the cherry tree has led to the tradition of celebrating Washington's birth with cherry pie instead of cake.



# 10 things you may not know about Abraham Lincoln



Thousands of books have been written about Abraham Lincoln, but there are still a few things you might not know. (Library of Congress, Prints and Photographs)

There's a lot about the 16th president that doesn't make it into textbooks.

There's no danger of people forgetting Abraham Lincoln. Some 15,000 books have been written about him. And that's not including U.S. history textbooks, which can't ignore his leadership during the Civil War.

So you may know a lot about the 16th president. But there are many things about Lincoln that don't make it into textbooks. To mark Lincoln's birthday (February 12), KidsPost asked Michelle Krowl, a Civil War and Reconstruction specialist at the Library of Congress, to share 10 things you may not know about one of the nation's most written-about presidents.

# 1. Lincoln spoke with a high-pitched voice.

You might think that such a tall, imposing man as Lincoln had a deep voice. But he didn't. Krowl describes his voice as "highpitched and reedy" in a Library of Congress blog post. People who heard Lincoln speak said his voice was at times "unpleasant." Krowl said that "for most listeners, however, the power of Lincoln's words soon outweighed any discordant note in his delivery."

# 2. He grew a beard after an 11-year-old girl suggested it.

Grace Bedell of Westfield, New York, wrote to Lincoln in October 1860 to suggest that the presidential candidate grow whiskers because "your face is so thin." "All the ladies like whiskers," she argued. She said the new look would earn him votes. Lincoln started growing a beard not long after. "It isn't known if Grace's letter was what prompted him to do so," Krowl said. "But Lincoln did reply to her letter, so she could have influenced his decision." ### 3. He wasn't a terrific speller.

The champion speaker and powerful writer had a weakness in spelling. The word "inaugural" was a problem. Krowl said in her blog post that Lincoln wrote - "inaugural" in a note to his secretary, John Hay, on his handwritten copy of his second inaugural address. "It's sort of amusing

and endearing that despite being the president and giving inaugural addresses, he routinely misspelled 'inaugural,' " Krowl said.

# 4. He once received a city as a Christmas present.

Union General William T. Sherman's 285mile "March to the Sea" in 1864 ended with the capture of Savannah, Georgia. "Sherman alerted President Lincoln of the capture with a telegram presenting Lincoln with Savannah as a Christmas present," Krowl said.

#### 5. He commuted to work in the summer.

The Lincolns left the White House during the summer and lived in a cottage at the Soldiers' Home. "Although the Soldiers' Home is just three miles away and very much in the city now, in Lincoln's day, it was out in the country," Krowl said.

Lincoln commuted to and from work on horseback, sometimes riding alone. (Wife Mary Todd Lincoln wasn't happy about that.) # 6. He often stored papers in his stovepipe hat.

Images of Lincoln often show him wearing a tall black hat. The hat was more than a fashion statement. Lincoln's law partner William H. Herndon described another function: "This hat of Lincoln's — a silk plug — was an extraordinary receptacle. It was his desk and his memorandum-book. ... Whenever in his reading or researches he wished to preserve an idea, he jotted it down on an envelope or stray piece of paper and placed it inside the lining. Afterwards when the memorandum was needed there was only one place to look for it." One such hat of Lincoln's is on display at the National Museum of American History.

## 7. He received a patent for an invention.

Lincoln liked to tinker, figuring out how things worked. He invented a device that would lift boats over shallow waters in rivers. In 1849, while serving in Congress, he received a patent for the device. (You can find a picture of it on the website of the National Museum of American History.) Lincoln remains the only president to have received a patent.

# 8. He was not the main speaker at Gettysburg.

Lincoln was invited to the dedication of the Soldiers' National Cemetery in Gettysburg, Pennsylvania. But the star was to be Edward Everett. "Everett was one of the best known and most regarded orators of the day, and he was the star attraction at the Gettysburg cemetery dedication," Krowl said. "Abraham Lincoln was invited . . . to make 'a few appropriate remarks.'" Everett spoke for about two hours, and Lincoln about two minutes. "Now, of course, Abraham Lincoln's Gettysburg Address is famous, and far fewer people remember Edward Everett and his oration," she said.

# 9. As a youth, he made his own math notebook.

Growing up on farms in <u>Kentucky</u> and <u>Indiana, Lincoln</u> had little time for school. He often borrowed books and studied on his own. "In the 1820s Lincoln assembled his own notebook to work on mathematical problems, known at the time as a sum book or cypher book," Krowl said. You can see a page of the sum book at <u>wapo.st/mathbook</u>.

10. He was an easygoing father.

Sons Willie and Tad Lincoln lived in the White House and were known for being rowdy. Krowl said that Herndon, Lincoln's law partner, wasn't thrilled with their father's reaction. "His children did much as they pleased. Many of their antics he approved, and he restrained them in nothing. . . . He was the most indulgent parent I have ever known," Herndon wrote. Julia Taft Bayne, whose brothers played with Tad and Willie, wrote in "Tad Lincoln's Father" that the president enjoyed the little distractions from the war. When the boys barged into his office to ask for a pardon for a doll accused of spying, Lincoln played along: "'And I only wish, Hay,' he said to his secretary, with a sort of sigh, 'they were all that easy.' "

When the Purple Heart Fire Truck debuted back in 2014, it was a way to show appreciation to veterans. Now, its creator, Vietnam vet and Purple Heart recipient Herb Delbridge, is looking for other veterans to keep his vision alive, reports richmond.com.

A debilitating stroke last year left
Delbridge unable to operate the fire truck,
which looked like the end of his mission.
However, the report notes that volunteers
from the Marine Corps League and the
Henrico County (VA) Fire Department have
put the apparatus back in "service."

The fire truck is a 1983 Ford diesel on which Delbridge spent tens of thousands of dollars restoring. Hand-painted designs of his time in Vietnam adorn the fire truck, as is George Washington, the creator of the Purple Heart.

Delbridge (Casey) of Rockville, and Andrew B. Delbridge of Beaverdam; his greatgrandchildren include Kent Delbridge, Colten Anderson, MacKenzie Delbridge and Savannah Delbridge. Mr. Delbridge is survived by his sisters Elaine D. Lynch of Lawrenceville, Virginia and Marion D. Warren of Santa Fe, Tennessee, one brother Jerry W. Delbridge of Emporia, Virginia.

He is preceded in death by his mother, Dossie G. Gordon and his father Herbert S. Delbridge, Sr.; sisters Barbara D. Webb and Nancy D. Singleton.

Mr. Delbridge served his country for two years in the United States Army and eight years in the United States Marine Corps. During his service, he earned many

medals for his actions in "The Bay of Pigs" threat and in "Operation Buffalo", one of the fiercest and costly battles in Vietnam. He achieved the rank of Staff Sergeant in the Marine Corps. While in Vietnam, he was wounded three times and received the Purple Heart Medal and is recognized in the Purple Heart Hall of Honor. He was a dedicated member of the James M. Slay Detachment #329 of the Marine Corps League and the Military Order of the Purple Heart – Chapter 1965. He was also a member of the American Legion and Disabled American Veterans. Mr. Delbridge was the founder and creator of the Purple Heart Firetruck, a rolling war memorial with airbrushed painted scenes depicting the realities of the Vietnam war. Since 2014 Mr. Delbridge has traveled throughout the State of Virginia attending parades, patriotic events, and community festivals to bring honor and recognition to all Veterans, and especially to remember the 58,317 who paid the ultimate price in Vietnam.

Tom and his wife Betty have been teaching Veterans that the Cane is way more than a crutch, calling their operation Cane Loyalty. These teachings are based on a martial Art known as Cane-Fu developed by Grand Master Shuey in the Lake Tahoe area.

Many people believe that the Cane is only for people with mobility issues – but it is quite the opposite! The cane can be used to get stronger to live longer, enhance one's balance, increase your flexibility, and of course aid in your defense. Strength, balance, and flexibility all play a very important role in building a good solid foundation. For most people, the idea of defense brings to mind attackers, however, we must also defend against slips, trips, and falls. Having your cane, practicing balance, and stretching will greatly reduce injuries if you should ever slip, trip, or fall. Your cane may prevent the fall from happening.

Of course, the cane can also be used against a physical attack. The best defense is to simply not be there. Practice Situational Awareness and always try to avoid a fight. Being aware of one's surroundings better prepares you and gives you time to react. Proper Situational Awareness could possibly steer you away from trouble.

Combining the foundation of strength, flexibility, and balance along with your knowledge from cane training, you will

always have the advantage of reach, and surprise!

Training Veterans is a passion of ours and we do it at no cost to the Veteran. We work with all ages and abilities. We have developed special training to accommodate our wheelchair Veterans and Veterans with various prosthetics.

Tom was recently honored as one of five Veterans here in Virginia to have a large mural painted of him and on permanent display at the Richmond Veterans Hospital in Richmond Virginia. This tribute, plus receiving a Quilt of Honor was received because of the large number of Veterans that Cane Loyalty has trained.

Many groups of Veterans have been trained.

We have had the honor to train Veterans representing all branches of the military and lucky enough to have had several World II Veterans attend as well as Korean Veterans, Vietnam Veterans and Veterans from the various Sand Boxes attend. Each Veteran that attends this training receives

an American made oak training cane. This is made possible through the generosity of Athletes and Veterans United.



# Never Too Late: A Case of Mistaken Identity and the Purple Heart Project

On 26 September 1918, USS *Tampa* was nine days into its 19th convoy escort, running low on coal. Her captain, Charles Satterlee, requested permission to detach from the convoy but was denied because of the risk of sailing alone in broad daylight in submarine-infested waters. He made a second request at 4 pm, as the coal bunkers were now dangerously low. This time, the request was granted. At 4:15 pm

Tampa detached and proceeded full steam ahead towards the Bristol Channel to make port at Milford Haven, Wales. With her lights extinguished as a security measure, Tampa, sailing alone at dusk with her silhouette visible against the night sky, was sighted by a German submarine, UB-91. At 8:15 pm, UB-91 fired off a torpedo, which blasted a hole in Tampa's hull amidships.

This was followed by a second explosion.
The 190-foot Coast Guard escort vessel sank with all hands in fewer than three minutes, just off Bristol Channel— seven weeks before the war ended.

This sinking would be the greatest single casualty incurred by any naval unit as a result of enemy action during the four- plus years of World War I. Tampa's crew totaled 130 men, including 111 Coast Guardsmen, four US Navy personnel, and 15 British Navy sailors and dockworkers.

#### The Tampa Purple Heart Project

The Purple Heart originated from an honor George Washington bestowed on a handful of Army soldiers during the Revolutionary War. It was originally called the Badge of Military Merit and was made of a purplish cloth in the shape of a heart with the word "merit" sewn across the center. At the time of Tampa's loss, the Purple Heart was not in use in any military service. General Douglas MacArthur, in his role as US Army Chief of Staff, had the medal restored as an Army decoration on 22 February 1932. After the attack on Pearl Harbor, President Franklin Delano Roosevelt extended eligibility to the Navy, Marine Corps, and Coast Guard. Finally, on 12 November 1952, President Harry S. Truman signed Executive Order 10409, allowing for the Purple Heart to be awarded retroactively for actions after 5 April 1917.

New eligibility criteria required recipients to have been wounded or to have died as a result of direct enemy action. This automatically made the crew of *Tampa* 

eligible for the Purple Heart, but her case was overlooked until 1999, when James Bunch, a retired Coast Guardsman, proposed to then COMDT James Loy that the Purple Heart be awarded posthumously to her crew. Eighty-two years after she sank, on 11 November 1999, Tampa's crew was recognized as Purple Heart recipients in a ceremony at the Coast Guard Memorial at Arlington National Cemetery. Three descendants of Tampa crewmembers received Purple Hearts on behalf of their ancestors. Today, more than 105 years after Tampa was lost and 24 years after the first Purple Heart was awarded to one of her crew, the Coast Guard has awarded 62 Purple Hearts to lost crewmembers from USS Tampa. Efforts are ongoing to identify families who have yet to receive their relatives' Purple Heart medals.

### A Case of Mistaken Identity

This is the story of one such crewman, (WT2) Charles E. Green, who is listed in Coast Guard records as "Frank C. Garrett," and his family's struggle to prove that Frank C. Garrett was, in fact, Charles E. Green and they should receive the Purple Heart on his behalf. Charles Green was born on 13 February 1899 in East Bernstadt, Kentucky, to Jasper and Margaret (Cloyd) Green; his sister Stella was born in July of 1900. Their mother and a younger sister both died in June of 1903 of a fever, when Charles was about four years old. His father remarried around 1904 to Ida Belle Rice. With that union, Ida brought her four-year-old son Lawrence into the family. At some point, the Greens moved to Marion, Illinois, where Charles's father worked as a teamster for the

mines. According to family lore, around 1916 Charles bought some items from the company store on his father's account without permission. His father's violent reaction caused Charles to run away from home. News of the altercation did not sit well with the townspeople, and they forced Jasper to leave town. The family moved to Shannon County, Missouri, where Jasper took up farming.

There is no record of where Charles went after running away, but given the timetable, it appears that he made his way to Florida, where on 9 January 1917—a month before his 18th birthday—he enlisted in the US Coast Guard under the alias "Frank Charles Garrett," using a false birth date of 5 January 1896, claiming to be 21 years old. He was assigned to USS Tampa as ordinary seaman. According to his service record, which his family only recently received, he appeared to have been a quick learner and good worker. He advanced rapidly from a "coal heaver" (on the job only seven days) to "fireman" (four days) advancing to "Water Tender A" (roughly equivalent to an E-4 Petty Officer today) for three months. He was promoted to Water Tender – 2nd class, a rating he held for ten months and thirteen days.

New Coast Guard recruit Charles Green, who enlisted under the alias "Frank Garrett" in January 1917, was assigned to USS *Tampa*. He and his shipmates perished when the *Tampa* was torpedoed by a German U-boat on 26 September 1918.



This photo of Charles Green taken on 25 January 1918 in Plymouth, England, is a perfect example of how young and full of pride these men were. The photo was taken just before his 19th birthday; his youth comes through clearly, but his true strength is revealed in his steady gaze. The tragedy of Charles Green's story at this point in time lay both behind him and ahead. He had become so estranged from his immediate family—in particular, his father— that he felt the need to distance himself from them to the point of changing his name. Eight months after this photo was taken, Tampa was torpedoed and sank, taking 130 souls to their watery graves in under three minutes. Seven weeks later, the war was over.

#### **Never Too Late**

In the decade immediately following the loss of the *Tampa*, families, friends, and former colleagues of the men who perished erected various memorials throughout towns, cities, and states as-sociated with the lost crew. Of these, several have plagues listing the names all the Coast

Guard crew, plus the four US Navy personnel and the British sailors and dockworkers who were also on board.

One of the most prominent memorials is the **US Coast Guard Memorial at Arlington** National Cemetery, which was dedicated on 23 May 1928. Architect George Howe and sculptor Gaston Lachaise captured the spirit of the Coast Guard's legendary steadfastness in the monument's rock foundation and pyramid design. Above the Coast Guard motto, Semper Paratus ("Always Ready"), a bronze seagull appears poised to take flight. The gull symbolizes the Coast Guard's tireless vigil over the nation's maritime territory. The names of the vessels Seneca and Tampa and their crewmen, as well as all Coast Guard personnel who lost their lives during World War I, are inscribed on the sides of the monument.

You will not find Charles Green's name on this monument or in any other Coast Guard record. His alias, Frank Garrett, can be found on the right side of the lower left panel—six names down from the top. This mere glitch in the historical record may seem insignificant, but even after 105 years the record can be corrected. Charles Green's relatives set out to prove, beyond a doubt, Frank Garrett's true identity, and they have succeeded. Charles Green's Purple Heart will be awarded to his family on Memorial Day, 2024. Green will be the 63rd. Tampa crewmember so recognized. The Purple Heart Project's work is ongoing to identify and recognize the remaining crewmembers eligible for this honor, men who gave the ultimate sacrifice for their country.

# Homes for Heroes Recipient

On 13 December 2023, Patriot Aaron P. Mankin, Chapter 460 (Fayetteville, AR) was presented the keys to his mortgage free home in Rogers, Arkansas from the Building Homes for Heroes organization, Horton Homes, Advanced Auto Parts, Lowes, and the Bobby Bones Show.

Patriot Mankin enlisted in the US Marine Corps in 2003 as a Combat Correspondent and deployed to Iraq in 2005 to tell the Marine Corps story in Operation Iraqi Freedom. On 11 May 2005, near the Syrian-Iraq border, Aaron was severely wounded when an improvised explosive device exploded underneath his amphibious assault vehicle (AAV) that killed four of his fellow Marines and wounded 11 others. The heat from the explosion was so hot, that when he tried to breath, he inhaled debris and fire into his lungs. In addition, while Aaron was able to exit the AAV, he was still on fire, but even stop, drop, and roll could not dampen the flames. Patriot Mankin was saved by the quick action of other Marines who came to his rescue and he walked away with burns on his torso, ears, mouth, nose, neck, arms; a few lost fingers; and damage to his lungs. Two days later, Aaron was at Brooke Army Medical Center in San Antonio, TX to begin his long and arduous recovery.

In 2007, Aaron was the first US Service member selected for Operation Mend at the University of California, Los Angeles where some of the Nation's best plastic surgeons volunteered their time and skills to repair and heal some of the Military's most baldly injured Troops. Aaron has undergone over 70 surgeries to date.

To repay Aaron for his service while in uniform and for his post-service support to his fellow Combat Wounded Veterans, The Bobby Bones Show, on 05 June 2023, notified Patriot Mankin he was selected for a house that will be built and adapted to his specific needs through the Building Homes for Heroes organization.

These days, Patriot Mankin is a powerful motivational speaker who spends his time inspiring other injured Veterans. He has been featured on major network television and in several national magazines. When not traveling across the United States, Aaron spends his time in Rogers, Arkansas where he resides with his family.

## **February is Black History Month**




When Carter G. Woodson established Negro History week in 1926, he realized the importance of providing a theme to focus the attention of the public. The intention has never been to dictate or limit the exploration of the Black experience, but to bring to the public's attention important developments that merit emphasis.

For those interested in the study of identity and ideology, an exploration of ASALH's Black History themes is itself instructive. Over the years, the themes reflect changes in how people of African descent in the United States have viewed themselves, the influence of social movements on racial ideologies, and the aspirations of the black community.

The changes notwithstanding, the list reveals an overarching continuity in ASALH—our dedication to exploring historical issues of importance to people of African descent and race relations in America.

### **The Origins of Black History Month**

2024 Theme- African Americans and the Arts



African American art is infused with African, Caribbean, and the Black American lived experiences. In the fields of visual and performing arts, literature, fashion, folklore, language, film, music, architecture, culinary and other forms of cultural expression, the African American influence has been paramount. African American artists have used art to preserve history and community memory as well as for empowerment. Artistic and cultural movements such as the New Negro, Black Arts, Black Renaissance, hip-hop, and Afrofuturism, have been led by people of African descent and set the standard for popular trends around the world. In 2024, we examine the varied history and life of African American arts and artisans.

For centuries Western intellectuals denied or minimized the contributions of people of African descent to the arts as well as history, even as their artistry in many genres was mimicked and/or stolen. However, we can still see the unbroken chain of Black art production from antiquity to the present, from Egypt across Africa, from Europe to the New World. Prior to the American Revolution, enslaved Africans of the Lowcountry began their more than a 300-year tradition of making sweetgrass baskets, revealing their visual artistry via craft.

The suffering of those in bondage gave birth to the spirituals, the nation's first contribution to music. Blues musicians such as Robert Johnson, McKinley 'Muddy Waters' Morganfield and Riley "BB" B. King created and nurtured a style of music that became the bedrock for gospel, soul, and other still popular (and evolving) forms of music. Black contributions to literature include works by poets like Phillis Wheatley, essays, autobiographies, and novels by writers such as David Walker and Maria Stewart. Black aesthetics have also been manifested through sculptors like Edmonia Lewis and painters like Henry O. Tanner.

In the 1920s and 30s, the rise of the Black Renaissance and New Negro Movement brought the Black Arts to an international stage. Members of the armed forces, such as James Reese Europe, and artists such as Langston Hughes, Josephine Baker and Lois Mailou Jones brought Black culture and Black American aesthetics internationally, and Black culture began its ascent to becoming a dominant cultural movement to the world. In addition to the Harlem

Renaissance, today we recognize that cities like Los Angeles, Chicago, and New Orleans also were home to many Black artists.

The 1960s continued this thread through the cultural evolution known as the Black Arts Movement, where artists covered issues such as pride in one's heritage and established art galleries and museum exhibitions to show their own work, as well as publications such as Black Art. This period brought us artists such as Alvin Ailey, Judith Jamison, Amiri Baraka, Nikki Giovanni, and Sonia Sanchez. The movement would not have been as impactful without the influences from the broader Black world, especially the Negritude movement and the writings of Frantz Fanon.

In 1973, in the Bronx, New York Black musicians (i.e., DJ Kool Herc and Coke La Rock) started a new genre of music called hip-hop, which comprises five foundational elements (DJing, MCing, Graffiti, Break Dancing and Beat Boxing). Hip-hop performers also used technological equipment such as turntables, synthesizers, drum machines, and samplers to make their songs. Since then hip-hop has continued to be a pivotal force in political, social, and cultural spaces and was a medium where issues such as racial violence in the inner city, sexism, economic disinvestment and others took the forefront.

The term Afrofuturism was used approximately 30 years ago in an effort to define cultural and artistic productions (music, literature, visual arts, etc.) that imagine a future for Black people without

oppressive systems and examines how Black history and knowledge intersects with technology and science. Afrofuturist elements can be found in the music of Sun Ra, Rashan Roland Kirk, Janelle Monáe and Jimi Hendrix. Other examples include sci-fi writer Octavia Butler's novels, Marvel film Black Panther, and artists such as British-Liberian painter Lina Iris Viktor, Kenyan-born sculptor Wangechi Mutu, and Caribbean writers and artists such as Nalo Hopkinson, and Grace Jones.

In celebrating the entire history of African Americans and the arts, the Association for the Study of African American Life and History (ASALH) puts into the national spotlight the richness of the past and present with an eye towards what the rest of the twenty-first century will bring. ASALH dedicates its 98th Annual Black History Theme to African Americans and the arts.

Veterans: All hands-on deck to remedy dire military recruiting situation

Only 9% of those 16 to 21 years old willing to serve

#### **OPINION:**

Fifty years ago, then-Secretary of Defense Melvin R. Laird announced the U.S. military would, in the future, fill its ranks exclusively with volunteers rather than with draftees. The all-volunteer force was created, and conscription had come to an end.

The all-volunteer military has worked for our country. There have been some rough periods through both peace and war, but for the most part, it has proved resilient — up until now.

To say the all-volunteer force has hit a rough spot would be an understatement. A better characterization would be that recruiting for the military services has become a dire situation. Despite significant bonuses, eased enlistment requirements and the creation of programs to help potential recruits qualify academically and physically before even entering boot camp, the only military services that met recruiting goals this past year are the Marine Corps and the <a href="SpaceForce">SpaceForce</a>. In fact, the services have struggled for the past couple of years to meet recruiting goals.

Part of the challenge in meeting our recruiting goals is interest in and eligibility for military service among young people. In addition to 77% of young Americans being ineligible to serve without a waiver for being overweight or having a history of drug use or mental or physical health issues, the propensity to serve has also dropped precipitously. Only 9% of those who are 16 to 21 years old are willing to serve.

In short, the nation is struggling to recruit and retain the <u>force</u> we need to defend our country and support our allies when called upon.

To turn this around, the services have raised the enlistment age, implemented new advertising campaigns, increased the use of social media and, in the Army's case, created a new structure for its recruiting command.

There is another tool in the toolkit that can help the services meet the recruiting challenge, and that tool should be called upon immediately: the veterans who have served this country in uniform.

Those of us who have served have wonderful experiences and stories to tell how our military service has shaped our lives. Each of us who has served or is serving can tout the professional and leadership skills we've developed, the friendships we've built, the travel opportunities we've enjoyed, the educational opportunities we've been provided, and the health benefits the military provides for its members and their families.

Reversing the recruiting situation is clearly a challenge. But who better to tell the military's story than those who have served and have benefited from all that the military has provided them? Quite simply, the military offers a rewarding experience — and it does not have to be a decades-long commitment. A four-year enlistment will suffice. Let the experience speak for itself. The opportunities are unmatched.

The services provide some extraordinary training opportunities. Be it repairing aircraft or shipboard power plants or being an air traffic controller or information technology professional, there is an opportunity to receive some expensive training and experiences that can be parlayed into a civilian career later.

There is a good chance that once these young people develop a camaraderie with their new peers, experience the mentorship and leadership they are provided and see their professional skills develop, some may choose to remain in the service.

I enlisted in the Navy when we had conscription. I did not see myself remaining for a career, not to mention wanting to earn an officer's commission. But it didn't take long for me to be the recipient of some great leaders — both officers and enlisted personnel — who cared about my personal growth, training, and overall well-being. They motivated me to seek a commission and to replicate the kind of leadership and skills I saw in them.

Those who have worn the uniform have the opportunity to tell the positive side of military service in order to keep the all-

volunteer force strong and successful. Those of us who experienced a conscripted military — especially those of us who had leadership responsibilities — know the problems and challenges that period brought. Those problems are the last thing this country and our military need.

We need only look at how Russian conscripts have performed in Ukraine to be reminded of what happens with a conscription military.

To prevent that from happening, veterans need to find ways to reach out to our young people — be influencers — and be advocates for the benefits of military service. In order to recruit and retain the <a href="high-quality force">high-quality force</a> needed to protect our nation, we must recognize that military service is a continuum, including those who serve today, those who have served in the past and those who will serve in the future.

The Military Officers Association of America, a nonprofit advocacy organization, sees its leadership and support for the <u>all-volunteer force</u> as one of its most sacred obligations. Its motto, "Never Stop Serving," is a mindset found across its membership. Protecting the <u>all-volunteer force</u> is part of the organization's strategic plan.

Accordingly, those of us who have served have an opportunity to have a role in attracting the next generation of military members. We must strive to tell the positive side of military service so that future generations will continue the 50-year legacy of success the <u>all-volunteer force</u> has enjoyed.





### **Hero's Medals Come Home**

On November 10, 2023, the day before Veterans Day, the family of Frank Joseph Gaffney ceremoniously returned to Niagara County to donate the decorations of a World War I veteran who was known as the second bravest man in the U.S. Army.



Niagara County officials honored WWI hero Private First-Class Frank Gaffney by creating a permanent display for his medals in the Niagara County Courthouse rotunda. Outside the courthouse, a Purple Heart Park was dedicated to Gaffney and all Purple Heart recipients on Purple Heart Day in August of 2023.

Gaffney, a Niagara County native enlisted in the Army when he was 33-years-old. Assigned to the 27th Infantry Brigade which was called into service in 1917, Gaffney and the 27th in 1918 were deployed to France to breach the Hindenburg Line.

On September 29, 1918, near Ronssoy, France, Private Gaffney, an automatic rifleman, pushed forward alone after other members of his squad had been killed or wounded. He discovered the enemy setting up a heavy machine gun position. Placing his gun on the parapet, he opened fire, killed the crew, captured the gun, eliminated several enemy who were dug in the trenches and killed four of the enemy with his pistol. He then held the position until reinforcements came up and helped with the 80 prisoners he had captured. His mission was successful, allowing the Allies to move in and helped lead to the end of the war.

Gaffney's story is nothing short of remarkable. He is credited for having a significant role in the battle of St. Quentin Canal Tunnel. Gaffney was wounded in combat, resulting in the amputation of his left arm.



His military honors include: The Congressional Medal of Honor, The Purple Heart, the Victory Medal, The Medaille Militaire and the Croix de Guerre of France, the Distinguished Conduct Medal of England, the Cruz de Guerra of Portugal, Montenegro Medal of Honor and the Italian Cross of Military Valor. Gaffney's family kept his medals and other artifacts from the war, but they say it's time to share them with the public in a permanent display.

"We've had these records and we've protected them and kept them safe. We felt it was time that they really need to be seen and not just be kept away and preserved. That was our intent," Theresa Foran, Gaffney's family member, said.

During the dedication ceremony, John Strasburg, an author who wrote a book "He Charged Alone", solely about Gaffney's service, emphasized the importance of keeping Gaffney's story in the forefront.

### **AR WWII Veteran Accounted For**

Nov 20, 2023 WASHINGTON—The Defense POW/MIA Accounting Agency (DPAA) announced today that U.S. Army Air Force 2nd Lt. Kenyon Brindley, 23, of Little Rock, Arkansas, killed during World War II, was accounted for Sept. 21, 2023.

In early 1944, Brindley was assigned to the 703rd Bombardment Squadron, 445th Bombardment Group, 8th Air Force in the European Theater. On Feb 24, Brindley, a bombardier onboard a B- 24J "Liberator", was killed in action when his plane was hit by heavy anti-aircraft fire over Gotha, Germany. One of the surviving crewmembers reported seeing the plane on fire and in a steep dive, before eventually exploding on the ground. While two crewmembers survived, the others, including Brindley, were killed in the incident. German forces garrisoned in the area documented the crash site north of

Leimbach Bahnhof, near Bad Salzungen, Germany. After the crash, German troops recovered the remains of the ball turret gunner and buried them in a local cemetery. The other six crewmembers, including Brindley, were unaccounted for following the war.

In March 1952, the American Graves Registration Command (AGRC), the organization that searched for and recovered fallen American personnel in the European Theater, took custody of comingled unidentified remains recovered from Bad Salzungen Cemetery. These remains, X-9093 Griesheim Mausoleum (X-9093), X-9094 Griesheim Mausoleum (X-9094), and X-9095 Griesheim Mausoleum (X-9095), were believed to be those belonging to 2nd Lt. Brindley's downed aircraft. At the time, identification of these remains was not possible, and they were interred in the Ardennes American Cemetery, Belgium.

In June 2021, DPAA historians and <u>American</u> <u>Battle Monuments Commission</u> personnel, exhumed X-9093, X-9094, and X-9095 from Ardennes American Cemetery and transferred them to the DPAA Laboratory for analysis and identification.

To identify Brindley's remains, scientists from DPAA used anthropological analysis. Additionally, scientists from the <u>Armed Forces Medical Examiner System</u> used mitochondrial DNA (mtDNA) analysis.

Brindley's name is recorded on the Tablets of the Missing at Henri-Chapelle American Cemetery, Hombourg, Belgium, along with others still missing from WWII. A rosette will

be placed next to his name to indicate he has been accounted for.

Brindley was buried on Dec. 18, 2023, in Conway, Arkansas.

Native American veterans celebrate congressional charter for National American Indian Veterans

SIOUX FALLS, S.D. (Dakota News Now) The Military Order of the Purple Heart's
chapter 5355 in Sioux Falls held its regular
monthly meeting Thursday at the South
Dakota Military Heritage Alliance. This
meeting was a special one with plenty to
celebrate. The chapter received a generous
donation of popcorn from the BSA Sioux
Council and a presentation of the Military
Order of the Purple Heart's regional Patriot

of the Year Award to <u>David Flute</u>, Secretary of the South Dakota Department of Tribal Relations. The cherry on top was the news from earlier in the day.

Until now, there has never been a congressional charter designated for Native American veterans despite many attempts. In May, Representative Dusty Johnson and Senator Mike Rounds made another attempt to establish one with the National American Indian Veterans Charter Bill. However, it was the 2024 National Defense Authorization Act that finally led to the establishment of a congressional charter for the already operating National American Indian Veterans organization, or NAIV.

"This is going to give our brothers and sisters, Native American brothers and sisters the power," said Ken Teunissen, a state Representative from District 9 and a Past Region III Commander of the Military Order of the Purple Heart. "Not only that, but then they'll be able to go to Congress and testify if they need, what they need, how much they need and their needs."

According to the U.S. Department of Defense, Native Americans serve in the armed forces at a rate <u>five times higher</u> than the national average. While other nationalities and religious groups currently have a recognized charter, veterans said that it's long overdue for a Native American congressional charter.

"I'm ecstatic because this is something that three or four years or five years of selling it and having Native American brothers and sisters no representation, so this is a milestone," described Teunissen. "I mean, this is a once in a lifetime."

Their contributions to the military have not gone unnoticed. One of Senator Rounds' motivations to get a congressional charter established was the work of a Korean War veteran and member of the Hunkpati Sioux Tribe, <a href="Don Loudner">Don Loudner</a>. Loudner served with Rounds' father and has been pushing for this representation for years.

"And after years of trying to get it done, this year it's included in the NDAA," said Rounds. "I'm proud of the work that Don's done and happy to deliver for him and for Native American veterans."

Finally seeing collective support and recognition has meant a lot to the community of Native American veterans.

"I appreciate the great work that has been done for the American Indian Veterans and would like to thank the delegation," said Flute.

"I think it's going to build a line of communication between the federal government and the National American Indian Veteran organization," explained Teunissen. "That's what it's all about."

The Military Order of the Purple Heart took time in their meeting to acknowledge and celebrate the 2024 National Defense Authorization Act passing in the U.S. House of Representatives and Senate. The Act will become official with the signature of President Biden. The bill is likely to be signed in January. Senator Rounds authored 33 provisions in the act, including the provision that established the charter.





Brian Easley, a former U.S. Army Infantry Staff Sergeant who was wounded November 22, 2003 in Ar Ramadi, Iraq, made a promise to himself after he was wounded to do great things - in honor of

those lost in Iraq and Afghanistan who no longer had the chance to.

Originally from San Antonio, Texas, Easley



has since completed his bachelor's degree and two master's degrees, gotten married and had three children, formed an indierock band called Exit Vehicles, published a book of poems titled The Bracken Road, and become a restaurant and real estate executive in the Midwest, nonprofit board member, as well as a film producer. Easley is currently producing a documentary film about a U.S. Navy veteran, singersongwriter, actor, rancher, river guide, and

Texas Poet Laureate named Steven Fromholz. The film is called <u>The Man with</u> <u>the Big Hat.</u>



Though five years in the making, and despite struggling to raise funds and shoot the film during the pandemic - as a Purple Heart recipient, Easley felt producing this film was part of a higher calling, raising awareness about wounded warriors and those with disabilities in the arts. Fromholz himself suffered a massive stroke several years before his passing and had to relearn many of his own songs. The Man with the Big Hat was produced alongside Three Chords And The Truth, an Austin, Texas nonprofit organization. The documentary will premiere in 2024, and hopefully feature in multiple film festivals world-wide. The director of the film is Austin Sayre; produced by Brian Easley and Stephanie Moore; photography and cinematography by Aaron Colussi and David Broad; sound by Miles Blunt; editing by Nevie Owens.



I have finally written a book about my upbringing, and what Vietnam did to me. I thought I would send you the link to look at.

The book "Face Of The Enemy" is now out through Book Locker.



It's so hard to realize that being a pleasant person when you are not becomes a bad

habit. I always thought that by working myself to death would be my salvation.

A lot of heartache went into this project. As with so many veterans, "The world breaks everyone, and afterward, some are strong at the broken places. Especially at the VA Central Office working at the Secretary's Office.

After over 25 years, I retired from Federal Express, and was brought on board at the VA Central Office working at the Secretary's Office Center For Minority Veterans where I was a Program Manager for Asian American and Pacific Islander Veterans benefits and Medical care. I also worked alongside with Native veterans and the Center for Women Veterans.

I was commissioned to bring the Vietnam Women's Memorial on a Whistle Stop Tour across America to the National Mall in Washington, D.C., thanks to Fred Smith at FedEx. I started on the ground floor when Mr. Smith came up with the idea of Federal Express. Most of us were Vietnam Veterans when the company began operations in Memphis TN. I was also on the Vietnam Women's Memorial Foundation Board Of Directors with Diane Carlson-Evans, who is the founder of the program, and was a combat nurse while in Vietnam. After leaving the VA in Washington, D.C., I was asked to be Chair of the Board of Directors for the Utah State Veterans Nursing Home.

Being the person to bring the Vietnam Women's Memorial on a Whistle Stop Tour across America was a healing hard to describe.



### Steel Soldier – Guadalcanal Odyssey Charles Messina



My father, the most influential person in my life, passed away on March 20, 2008. As an intimate gift to his children, he wrote and illustrated his life story.

In the end, it took him eight years to

complete his autobiography, and I was so impressed with his storytelling and artistic talent that I reached out to a journalist who had an interest in regional history.

Following an interview with my father, the local newspaper ran a two-page article chronicling his life growing up in West Aliquippa, Pennsylvania, and his time serving as a Marine in World War II. The journalist applauded his work as an enormous achievement and an important part of history. He encouraged me to publish his story and share it with the public, which is something I had wanted to do for a long time. However, my dad was not interested and said it was merely a token of love for his children to remember him by.

This is an American tale about a working-class man who lived an honest life, believed strongly in God, and fought for his country. He represents thousands of other hardworking Americans with untold stories of integrity and honor. It's also a compelling story of survival that begins in a gritty Pennsylvania steel town during the Great Depression and then transports the reader into the steaming jungles of Guadalcanal, where a young Marine faces death in one of the most pivotal and bloodiest battles of World War II.

Steel Soldier serves as a testament to the special man my dad was. It's not a

gripping mystery that concludes with a thrilling climax. Rather, it is a series of vignettes with some entertaining moments of a bygone era, which have been compiled by a very talented storyteller.

To look at him, you'd never guess this mild-mannered, unassuming, and kind man had once been a fierce warrior. As long as I live, I will always admire and honor my father and all the men and women who have fought for this country. He was loved by everyone who knew him, and to me he is a true American hero.


